ADDITIONS AND AMENDMENTS TO THE ARTICLES AND SCHEDULES OF THE CONSTITUTION

The additions and amendments to the Articles and Schedules listed below were agreed to by the Federal Council at its virtual meeting of 8 April 2026. The Articles will become effective **immediately** and the Schedules on **01 July 2026** or as otherwise stated.

Clubs are reminded that in terms of Article 40 of the Constitution, Affiliated Clubs have the right to object to any proposed amendment or part thereof to the Articles, but this does not extend to the Schedules which are governed by Article 41 of the Constitution.

AMENDMENTS TO THE ARTICLES

Article 16.2.3 – Appeals Committee

Amend to read:

- 16.2.3 The Federal Council shall appoint sub-committees and in addition shall have the power to fill any casual vacancy on the Executive Committee provided the Councillor so co-opted is acceptable to
- 16.2.4 the majority of the Provincial Council Members. The Federal Council shall appoint at least three (3) persons, comprising either Provincial Council Members of the Federal Council, or external, independent persons, with appropriate knowledge and experience, or persons from either grouping in any combination to act as an Fedco Appeals Committee (FAC) to consider any appeals which may have been lodged in terms of the Disciplinary Rules. The appointed FAC shall elect a person from its number to chair the FAC.

12. APPEALS PROCEDURE

- 12.6 Should the SCI be satisfied with the Notice of Appeal it shall, after receipt of any response from the Respondent, forward all the documents to the Fedco Appeals Committee (FAC), as appointed by the Federal Council in terms of Article 16.2.3 of the KUSA Constitution, to consider the appeal.
