This report serves as a record of the KUSA Schedule 5C(3) Natural Ability Test held at Boavida Estate, Hartbeeshoek, on Friday, 13 March 2026.

The test was conducted in accordance with the applicable provisions of KUSA Schedule 5C(3). The venue provided suitable, representative terrain to assess the natural abilities of the participating dogs across all required components.

A total of 10 dogs were entered; 10 were presented and tested.

The appointed judging panel was as follows:

- **Ms Mariann Wilson** – Judge
- **Mr Steve Smith** – Judge
- **Ms Renée Minny** – Conformation Judge

The judges performed their duties consistently and in a structured manner, applying the prescribed standards uniformly across all entries.

The following officials were appointed to support the test:

- **Field Stewards:** Ms Elma Human
- **Gunner:** Mr Barry Greenwood-Selby

The test was conducted in an orderly and controlled manner, with appropriate coordination between judges, officials, and handlers. The presence and performance of the field stewards and the gunner contributed to the efficient execution of the test programme.

All dogs were assessed on their natural abilities as prescribed, including but not limited to search, pointing instinct, tracking, water work, and cooperation. The general standard of entries was satisfactory, and handlers conducted themselves in a sportsmanlike manner throughout the event.

No material incidents or deviations from the prescribed regulations were observed that would impact the validity of the test or the results obtained.
