## **KUSA SCHEDULE 5C(4): SHOOTING RATINGS - REPORT**

**Saturday, 14 March 2026**

**Boavida Estate, Hartbeeshoek**

This report serves as a record of the KUSA Schedule 5C(4) Shooting Ratings Test held at Boavida Estate, Hartbeeshoek, on Saturday, 14 March 2026.

The test was conducted in accordance with the applicable provisions of KUSA Schedule 5C(4). The venue provided suitable, representative terrain to evaluate the dogs' performance across the relevant shooting and retrieving disciplines.

The following classes were presented:

- Novice Shooting Dog (NSD)
- Shooting Dog (SD)
- Novice Retrieving Dog (NRD)

A total of 10 dogs were entered; 10 were presented and tested.

The appointed judging panel was as follows:

- **Ms Lize Venter** – Chief Judge
- **Ms Mariann Wilson** – Judge
- **Mr Steve Smith** – Judge

The judges carried out their duties consistently and in a structured manner, ensuring that all dogs were assessed in accordance with the prescribed standards and requirements of the relevant classes.

The following officials were appointed to support the test:

- **Field Stewards:** Ms Elma Human
- **Gunner:** Mr Barry Greenwood-Selby

The test was conducted in an orderly and controlled manner, with effective coordination between judges, officials, and handlers. The field arrangements and execution of shooting scenarios enabled a fair and practical evaluation of each dog's steadiness, marking ability, retrieving performance, and overall cooperation.

The general standard of dogs presented was satisfactory, and handlers conducted themselves in a sportsmanlike manner throughout the event.

No material incidents or deviations from the prescribed regulations were observed that would affect the integrity or validity of the test or its results.

No tests were conducted on Sunday, 15 March 2026, as no entries were received for the Shooting Dog Excellent (SDX) and Retrieving Dog (RD) classes.
